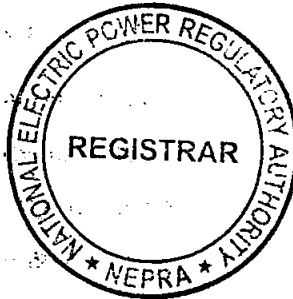



The Authority hereby grants Generation Licence to Mst.
