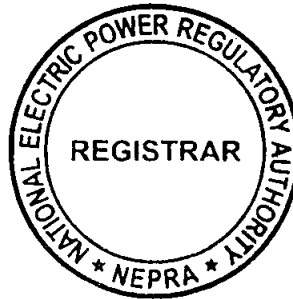

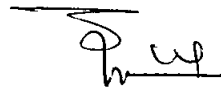

The Authority hereby grants Generation Licence to Mr. Monem Akber, for 10.70 KW photovoltaic solar based distributed generation facility, having consumer reference number 60288, located at House No. 288-F, Phase-XII, DHA EME, Lahore under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
