The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to \*Aziz Fatimah Trust Hospital having consumer **Reference Number 28 13124 5401200 U** located at Gulistan Colony, Faisalabad. This Licence is being issued in lieu of the earlier Licence dated July 06, 2021 to incorporate the enhancement in the capacity from 332.50 KW to 750.460 KW.
