The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Adeel Ahmad** having consumer **Reference Number 24 13125 5505865 U** located at Chak No.119, JB Samana Road, Faisalabad. This Concurrence is being issued in lieu of the earlier Concurrence dated March 29, 2024 to incorporate the enhancement in the capacity from 52.530 KW to 143.910 KW.
