The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to * **Faisal Abbas** having consumer **Reference Number 24 13343 5404400 U** located at Faisal Rice Mills Muza Pubar Wala Jhang. This Concurrence is being issued in lieu of the earlier Concurrence dated May 27, 2024 to incorporate the enhancement in the capacity from 210.600 KW to 463.32 KW. However its term of seven (07) years will remain the same and expire on 26th day of May 2031.
