The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \***Bilal Ramzan** having consumer **Reference Number 24 13153 5312253 U** located at ASF Textile Plot No.04, VAC, Khurrianwala. This Concurrence is being issued in lieu of the earlier Concurrence dated August 30, 2024 to incorporate the enhancement in the capacity from 41.400 KW to 143.880 KW. 3. The technical parameters of the Net Metering arrangements are as under:-


