The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Saleem Raza** having consumer **Reference Number 24 13123 5304271 U** located at Near Khawaja Cotton Factory Makkah Estate Small Road, Chak No. 07, Faisalabad. This Concurrence is being issued in lieu of the earlier Concurrence dated April 30, 2025 to incorporate the enhancement in the capacity from 60.700 KW to 115.880 KW. However its term of seven (07) years will remain the same and expire on 29th day of April 2032.
