
The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Muhammad Shahid Javaid** having consumer **Reference Number 24 13215 5501535 R** located at Chak No.67/JB Base Line Jhang Road, Faisalabad. This Concurrence is being issued in lieu of the earlier Concurrence dated February 26, 2024 to incorporate the enhancement in the capacity from 31.900 KW to 56.470 KW. However its term of seven (07) years will remain the same and expire on 25th day of February 2031.
