The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to *Kohinoor Sugar Mills having consumer Reference Number 24 13441 5101400 U located at Kohinoor Sugar Mills for B Type Colony, Jauharabad. This Licence is being issued in lieu of the earlier Licence dated October 31, 2022 to incorporate the enhancement in the capacity from 59.950 KW to 120.405 KW. However its term of seven (07) years will remain the same and expire on 30th day of October 2029.
