
The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to ***Mr. Muhammad Farooq Tariq** having consumer **Reference Number 24 13125 5506673 U** located at Chak No.08/JB, Sargodha Road, Faisalabad. This Licence is being issued in lieu of the earlier Licence dated March 29, 2023 to incorporate the enhancement in the capacity from 102.300 KW to 489.750 KW. However its term of seven (07) years will remain the same and expire on 28th day of March 2030.

2. The beneficiary shall abide by the provisions under the A&RE Regulations, as amended from time to time.
