

This Concurrence is being issued in lieu of the earlier Concurrence dated July 18, 2024 to incorporate the enhancement in the capacity from 63.560 KW to 99.040 KW. However its term of seven (07) years will remain the same and expire on 17<sup>th</sup> day of July 2031.
