The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Sh. Shahid Pervaiz Akhtar** having consumer **Reference Number 24 13138 5888015 R** located at Chak No. 209 RB, Karat Wala Road, Faisalabad. This Concurrence is being issued in lieu of the earlier Concurrence dated December 19, 2023 to incorporate the enhancement in the capacity from 216.300 KW to 287.100 KW.
