

This Concurrence is being issued in lieu of the earlier Concurrence dated July 11, 2025 to incorporate the enhancement in the capacity from 38.610 KW to 299.520 KW. However its term of seven (07) years will remain the same and expire on 10<sup>th</sup> day of July 2032.
