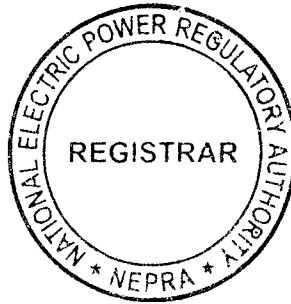

The Authority hereby grants Generation Licence to Mr. Abdul Rehman, for 5.0 KW photovoltaic solar based distributed generation facility, having consumer reference number 10-12422-0589055 R, located at Paki Kotli, Sialkot under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
