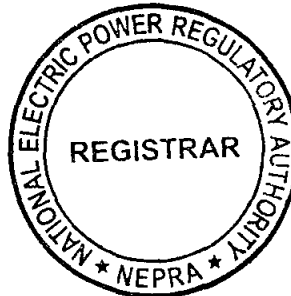

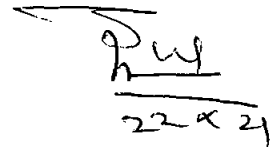

**GENERATION LICENCE**

The Authority hereby grants Generation Licence to Mr. Irfan Mehmood, for 8.640 KW photovoltaic solar based distributed generation facility, having consumer reference number 29 12211 0010400, located at Chah Kalar Wala Ghakar Mandi, Gujranwala under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 21<sup>st</sup> day of Oct, 2028.
