The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to *AI-Noor Hospial C/o Ijaz Aslam having consumer Reference Number 28 12443 0024802 R located at Klaswala Road, PSR-III.
