The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to ***Noble Rice Mill C/o Muhammad Zahid** having consumer **Reference Number 30 12153 1233700 R** located at Kamokee Road, T/Aali Opposite Sardar Rice Mill. This Licence is being issued in lieu of the earlier Licence dated May 02, 2025 to incorporate the enhancement in the capacity from 99.510 KW to 999.515 KW. However its term of seven (07) years will remain the same and expire on 05th day of January 2029.
