

This Concurrence is being issued in lieu of the earlier Concurrence dated November 21, 2023 to incorporate the enhancement in the capacity from 120.435 KW to 245.625 KW. However its term of seven (07) years will remain the same and expire on 20<sup>th</sup> day of November 2030.
