The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to \*Matco Rice Processing (Pvt.) Ltd. c/o Javed Ali Ghori having consumer Reference Number 30 12143 1192600 R located at G.T Road, Sadhoke. This Licence is being issued in lieu of the earlier Licence dated January 11, 2021 to incorporate the enhancement in the capacity from 463.760 KW to 944.450 KW. However its term of seven (07) years will remain the same and expire on 10th day of January 2027.
