

The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \* **Chaudhry Sami Ullah Khan Sahi** having consumer **Reference Number 30 12253 0000150 U** located at Buraq Maize Products Village Baran Da Walgan Sukheke. This Concurrence is being issued in lieu of the earlier Concurrence dated November 15, 2024 to incorporate the enhancement in the capacity from 242.19 KW to 354.96 KW. However its term of seven (07) years will remain the same and expire on 14<sup>th</sup> day of November 2031.
