The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \*Durable Hospital Suppliers C/o Bilal Tanveer having consumer Reference Number 30 12472 1775001 R located at Mandair Kalan Sialkot. This Concurrence is being issued in lieu of the earlier Concurrence dated August 30, 2024 to incorporate the enhancement in the capacity from 59.890 KW to 129.870 KW. However its term of seven (07) years will remain the same and expire on 29<sup>th</sup> day of August 2031.
