The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Rice Expert Enterprises C/o Umer Liaqat Bhandari** having consumer **Reference Number 30 12143 1191302 U** located at Kamoke District Gujranwala. This Concurrence is being issued in lieu of the earlier Concurrence dated June 03, 2024 to incorporate the enhancement in the capacity from 221.200 KW to 700.525 KW.
