The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to ***Aroop Flour & General Mill C/o Fawad Ahmed Khan** having consumer **Reference Number 30 12212 2259803 U** located at Near Nandi Pur Power, Gujranwala. This Licence is being issued in lieu of the earlier Licence dated March 13, 2024 to incorporate the enhancement in the capacity from 129.600 KW to 458.700 KW. However its term of seven (07) years will remain the same and expire on 05th day of January 2029.
