

The Authority hereby grants Generation Licence to Zafar Iqbal Poultry Farm for 156.24 KW photovoltaic solar based distributed generation facility, having consumer reference number 24 37225 0004108 R, located at Super Highway Nooriabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
