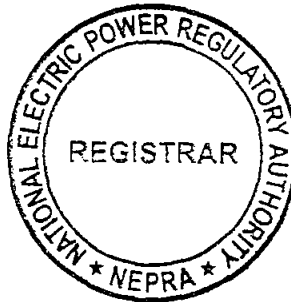



The Authority hereby grants Generation Licence to Allah Bux Poultry Shed for 50.29 KW photovoltaic solar based distributed generation facility, having consumer reference number 24-37254-0061645 R, located at Near Dado Mori B.S.K. Distt: T.M. Khan under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
