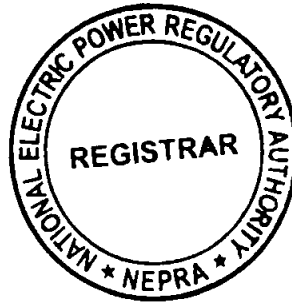



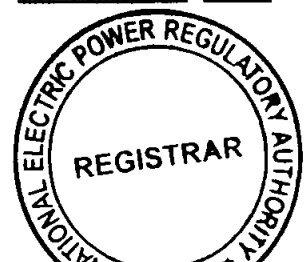

WHEREAS, National Electric Power Regulatory Authority (hereinafter referred to as "the Authority") has issued the NEPRA (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (hereinafter referred to as "the A&RE Regulations") to establish a framework for the regulation of Distributed Generation by using alternative and renewable energy and net metering;

2. **AND WHEREAS**, under Regulation-4 of the A&RE Regulations, IESCO through its letter dated November 3, 2016 forwarded the application of Mr. Javed Raza Khan, (hereinafter referred to as "the Applicant") along with relevant documents for the grant of Distributed Generation and Net Metering Licence for 10 kW distributed solar power generation facility, having Consumer Reference Number 11-14213-2692700U, located at House No. 24-C, Street No. 27, Margalla View Housing Scheme, Sector D-17/2, Islamabad;

4. **AND WHEREAS**, the Case Officer Report concludes that the Applicant has submitted the requisite documents and fulfils the eligibility criteria as provided in Regulation-4 of the A&RE Regulations;

5. **NOW THEREFORE, IT IS RESOLVED** that in view of foregoing, application filed under the A&RE Regulations by the Applicant is approved and the Applicant is hereby granted Distributed Generation and Net Metering Licence for 10 kW located at House No. 24-C, Street No. 27, Margalla View Housing Scheme, Sector D-17/2, Islamabad.

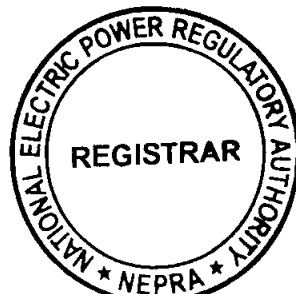

Case Officer Report
Regarding Application of Mr. Javed Raza Khan for the Grant of
Distributed Generation/Net Metering Licence


IESCO through its letter dated November 3, 2016 has forwarded the application of Mr. Javed Raza Khan (the Applicant) along with relevant documents for the grant of Distributed Generation/Net Metering Licence for 10 kW distributed solar power generation facility located at House No. 24-C, Street No. 27, Margalla View Housing Scheme, Sector D-17/2, Islamabad, under NEPRA (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the A&RE Regulations) (F/A).

(2). In this regard, IESCO has confirmed that Mr. Javed Raza Khan is its three-phase consumer having Consumer Reference No. 11-14213-2692700U. Under Regulation-4 of the A&RE Regulations, the Applicant, for grant of Distributed Generation/Net Metering Licence, is required to submit the following documents:

- (a). Net Metering arrangement agreement between consumer and the concerned distribution company.
- (b). Application for exemption from the requirement of Section-24 of the NEPRA Act as specified in Schedule-IV.
- (c). Evidence of deposit of fee as specified in Schedule-V.
- (d). Affidavit by distributed generator as specified in Schedule-VI.

(3). The Licensing Department has examined the submitted application of the Applicant and in this regard, it is confirmed that the said application fulfils the above mentioned criteria for grant of Distributed Generation/Net Metering Licence. Therefore, the Licensing Department recommends the grant of Distributed Generation/Net Metering Licence to the Applicant.

(4). In view of the above, this working paper is submitted for perusal of the Members of the Authority and approval of grant of Distributed Generation/Net Metering Licence to Mr. Javed Raza Khan.
