**Regarding Application of Mr. Tariq Rashid for the Grant of**  
**Distributed Generation/Net Metering Licence**


IESCO, through its letter dated April 14, 2017, has forwarded the application of Mr. Tariq Rashid, (the Applicant) along with relevant documents for grant of Distributed Generation/Net Metering Licence for 1.936 KW distributed solar power generation facility located at House No. 15, Lane No. 6, Sector H, DHA Phase-II, Islamabad, under the NEPRA (Alternate & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 ("the A&RE Regulations")

(2). In this regard, IESCO has confirmed that the Applicant is three-phase consumer having reference no. 15 14336 2548400 U. Under Regulation-4 of the A&RE Regulations, the Applicant, for grant of Distributed Generation/Net Metering Licence, is required to submit the following documents:

- (a). Net Metering agreement between consumer and the concerned distribution company;
- (b). Application for exemption from the requirement of Section-24 of the NEPRA Act as specified in schedule-IV;
- (c). Evidence of deposit of fee as may be specified by the Authority as specified in schedule-V;
- (d). Affidavit by distributed generator as specified in schedule-VI.

(3). The Licensing Department has examined the application of the Applicant and in this regard, it is confirmed that the said application fulfils the above mentioned criteria for grant of Distributed Generation/Net Metering Licence. Therefore, the Licensing Department recommends the grant of Distributed Generation/Net Metering Licence to the Applicant.

(4). In view of the above, this Case Officer Report is submitted for perusal of the Authority and approval for grant of Distributed Generation/Net Metering Licence to Mr. Tariq Rashid.
