Case Officer Report
Regarding Application of Mr. Muhammad Saeed for the Grant of
Distributed Generation Net Metering Licence


In terms of the NEPRA (Alternate & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations"), IESCO, through its letter dated August 23, 2019, has forwarded the application of Mr. Muhammad Saeed (the "Applicant") along with relevant documents for grant of Distributed Generation Net Metering Licence for 5.94 KW photovoltaic solar based Distributed Generation facility. The said Distributed Generation facility is located at, Humak Model Town, Islamabad.

(2). In this regard, IESCO has confirmed that the Applicant is its three-phase consumer and have Reference No. 10-14336-2017802 R. Further, the review of the application revealed that the Applicant is a residential consumer of IESCO having consumer tariff category A-1b(03)T and sanctioned load 11.0 kW. Under Regulation-4 of the A&RE Regulations, the Applicant, for grant of Distributed Generation Net Metering Licence, is required to submit the following documents:

- (a). Net Metering agreement between consumer and the concerned distribution company as specified in Schedule-I;
- (b). Application for exemption from the requirement of Section-24 of the NEPRA Act as specified in Schedule-IV;
- (c). Evidence of deposit of fee as may be specified by the Authority as specified in Schedule-V;
- (d). Affidavit by distributed generator as specified in Schedule-VI.

(3). The Licensing Department has examined the application and found that the said application fulfils the above-mentioned criteria for grant of Distributed Generation Net Metering Licence. Therefore, the Licensing Department recommends the grant of Distributed Generation Net Metering Licence to the Applicant.

(4). In view of the above, this COR is submitted for perusal of the Authority and approval for grant of Distributed Generation Net Metering Licence to Mr. Muhammad Saeed.
