The Authority hereby grants Generation Licence to Mr. Tariq Ubaid Ullah, for 5.13 kW photovoltaic solar based distributed generation facility, having consumer reference number 12-14336-2614600U, located at House No. 78, Street No. 2, Sector-B, Phase-II, DHA, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
