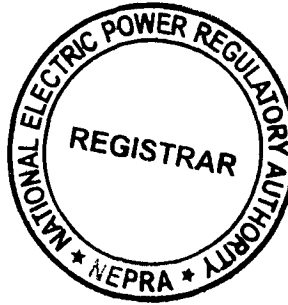



The Authority hereby grants Generation Licence to Brig. (R) Aftab Sadiq, for 5.12 kW photovoltaic solar based distributed generation facility, having consumer reference number 14-14336-2879100U, located at House No. 12, Street No. 12, Sector-E, DHA Phase-II, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
