



The Authority hereby grants Generation Licence to Mr. Abdul Aziz Tahir, for 5.12 kW photovoltaic solar based distributed generation facility, having consumer reference number 08-14127-1913900U, located at House No. 74, Sector D-12/1, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 
