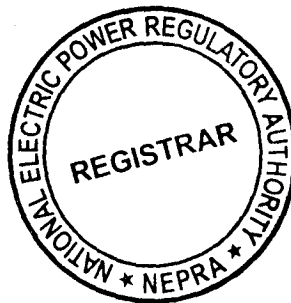

The Authority hereby grants Generation Licence to Mr. Rahim Zad Khan, for 9.12 kW photovoltaic solar based distributed generation facility, having consumer reference number 01-14118-0048800U, located at House No. 01, Street No. 09, Block-D, Naval Anchorage, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 
