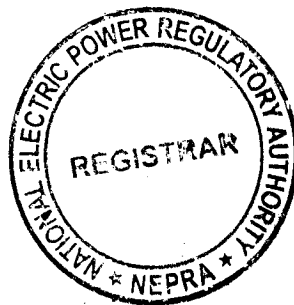



The Authority hereby grants Generation Licence to Mrs. Adeela Mir, for 5.20 kW photovoltaic solar based distributed generation facility, having consumer reference number 12-14336-2544601U, located at Plot No. 13, Street No. 01, Sector-A, DHA Phase-II, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 

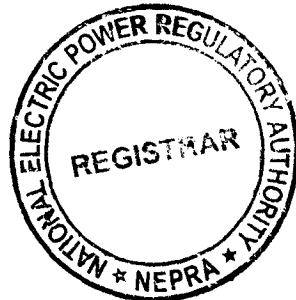
