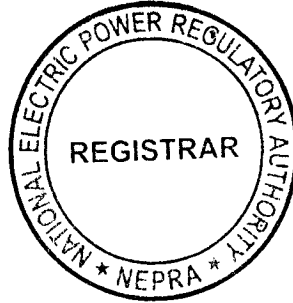



The Authority hereby grants Generation Licence to Ch.
