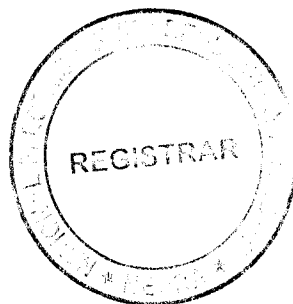



The Authority hereby grants Generation Licence to Mrs. Momina Paracha, for 5.40 KW photovoltaic solar based distributed generation facility, having consumer reference number 14 14336 3002001 U, located at Plot # 09, Street # 09, Sector-G, DHA II, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
