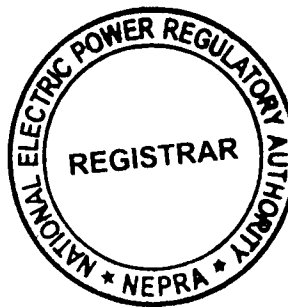

The Authority hereby grants Generation Licence to Mrs. Shala Aziz, for 22.08 KW photovoltaic solar based distributed generation facility, having consumer reference number 14-14119-3125700 U, located at Plot # 43, Scheme # 2, Sehana, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
