



The Authority hereby grants Generation Licence to Mr. Saleem Ahmad, for 5.20 KW photovoltaic solar based distributed generation facility, having consumer reference number 01 14362 0156600 U, located at House # 1395, Street # 30B, Sector II, Gulshan E Abad, Rawalpindi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
