The Authority hereby grants Generation Licence to Gen. Abdul Qayyum, for 10.68 KW photovoltaic solar based distributed generation facility, having consumer reference number 03 14127 0527900 U, located at House # 257 F.F, Margalla Road, F-11/2, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
