

The Authority hereby grants Generation Licence to Mr. Rasikh Maqsood, for 10.35 KW photovoltaic solar based distributed generation facility, having consumer reference number 07 14615 1517200 U, located at House No. 07, Street-D, DHA-I Islamabad, under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to -  $6^{44}$  day of 5 = 0.2028.
