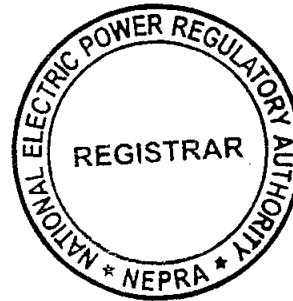



The Authority hereby grants Generation Licence to Mr. Amjad Hussain, for 5.40 KW photovoltaic solar based distributed generation facility, having consumer reference number 07 14123 1207000 U, located at House No.36, Street No.33, Sector G-9/1, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
