

The Authority hereby grants Generation Licence to Mst. Shabana Atif Khan, for 12.84 KW photovoltaic solar based distributed generation facility, having consumer reference number 02 14127 0215700 U, located at House # 69, Street # 59, Sector F-11/4, Islamabad under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
