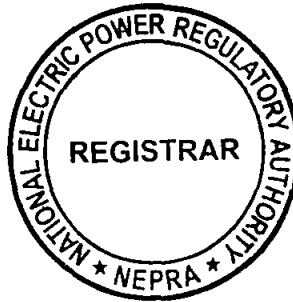




The Authority hereby grants Generation Licence to Malik Ahmed Khan, for 10.800 KW photovoltaic solar based distributed generation facility, having consumer reference number 28 14514 8656000 R, located at Village Dhoke Ali Khan, distt. Miamwale Talagang, under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
