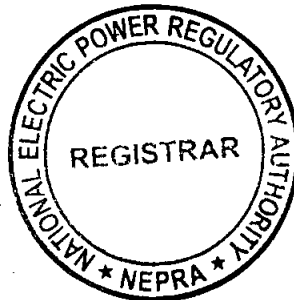



The Authority hereby grants Generation Licence to Mr. Tahir Mehmood, for 14.700 KW photovoltaic solar based distributed generation facility, having consumer reference number 03 14321 0357400, located at House.CB-786 Lane No.4, Tulsa Road Lalazar Rawalpindi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
