The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Muhammad Shahid Saghir** having consumer **Reference Number 28 14631 7080201 R** located at Plot No.03-A, Street No.S-6, RCCI, Rawat, Islamabad. This Concurrence is being issued in lieu of the earlier Concurrence dated May 21, 2025 to incorporate the reduction in the capacity from 85.840 KW to 79.460 KW. 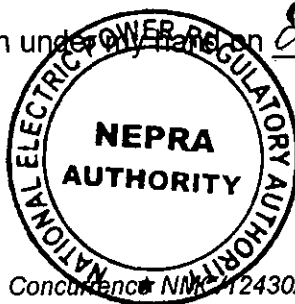
