The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \*Shaheen Flour & General Mills C/o Sheikh Ahsan Anwar having consumer Reference Number 27 14216 3661500 U located at G.T Road, Wah Cantt, Rawalpindi.
