The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \*Nawazish Flour Mills C/o Sheikh Shahid Masood having consumer Reference Number 27 14213 3323202 U located at Near Ibrahim Flour Mills Muslim Colony Taxila. This Concurrence is being issued in lieu of the earlier Concurrence dated September 20, 2024 to incorporate the enhancement in the capacity from 199.485 KW to 494.710 KW. However its term of seven (07) years will remain the same and expire on 19th day of September 2031.
