The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to **\*NFRID Army Welfare School & College for Boys** having consumer **Reference Number 27 14631 7492800 U** located at Rawat, Islamabad. This Licence is being issued in lieu of the earlier Licence dated October 19, 2022 to incorporate the enhancement in the capacity from 50.685 KW to 149.755 KW. However its term of seven (07) years will remain the same and expire on 18<sup>th</sup> day of October 2029.

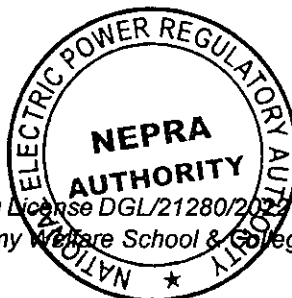
