The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to \*Imtiaz Ahmed having consumer Reference Number 27 14243 4106000 U located at Usman Floor Mills, Awan Abad, Kamara Road, Attock. This Licence is being issued in lieu of the earlier Licence dated December 21, 2022 to incorporate the enhancement in the capacity from 200.880 KW to 400.970 KW. However its term of seven (07) years will remain the same and expire on 20th day of December 2029.
