The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \*Mubarak Dad having consumer Reference Number 27 14243 4103401 U located at GT Road, Hattian, Attock. This Concurrence is being issued in lieu of the earlier Concurrence dated August 13, 2024 to incorporate the enhancement in the capacity from 216.450 KW to 366.795 KW. However its term of seven (07) years will remain the same and expire on 12th day of August 2031.
