The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to *Shaikh Muhammad Zubair having consumer Reference Number 27 16431 7504510 U located at Plot No.66, Kahuta Road, Sihala, Islamabad. This Concurrence is being issued in lieu of the earlier Concurrence dated October 19, 2023 to incorporate the enhancement in the capacity from 101.010 KW to 345.950 KW.
